





## **Daily Average Volume Traded (PER SECURITY)**



- The top 3 most liquid securities as measured by DAVT, were MASSY, GKC and JMMBGL for the month of August 2023. AMBL, AMCL and CALYP's monthly performance is above its respective 12-month moving average by 91%, 58% and 56% respectively.
- MASSY took the lead with the largest number of transactions (277) during the month of August 2023; followed by RFHL which reported a total of 253 trades, then NGL which reported 160 trades.
- UCL and NGL traded on all 21 trading days while FCGFH, RFHL, SBTT and MASSY traded on 20 out of the 21 trading days during the month of August 2023.

Across the First-Tier, Mutual Fund and SME markets, the cumulative number of trades in August 2023 was 1,758, a decrease of 89 trades or 4.82% compared to the trading activity in July 2023.

On a YOY basis, total trades recorded in August 2023 decreased by 300 or 14.58% over August 2022's trading activity.

On a YTD basis, total trades amounted to 14,945, representing a decrease of 682 trades or 4.36% over the equivalent YTD period in 2022.

On average, there were 84 daily trades recorded in August 2023 (July 2023: 88 trades), in comparison to a daily average of 98 trades recorded during August 2022.



In August 2023, UCL reported a market turnover ratio of 0.91%, followed by NGL and RFHL whose ratios stood at 0.17% and 0.13% respectively. Conversely, of all the securities traded, FCI reported the lowest market turnover ratio of 0.002%.

#### YTD



For equity securities, on a YTD basis, UCL reported a market turnover ratio of 8.32%, followed by NEL and MASSY, which reported turnover ratios of 1.94% and 1.87%, respectively. Conversely, of all the securities traded, EHL and CINE1 recorded the lowest YTD market turnover performances of 0.061% and 0.055%, respectively.
