


Daily Average Volume Traded (BY MARKET)



- The top 3 most liquid securities as measured by DAVT, were MASSY, NEL and FCI for the month of January 2024. AMBL (133%), NFM (98%), AMCL (95%), FCI (51%), EHL (36%), PHL (34%), AGL (15%), WCO (8%), PLD (6%) and FCGFH (5%) monthly performance are above its respective 12month moving average.
- MASSY took the lead with the largest number of transactions (267) during the month of January 2024; followed by RFHL with 252 trades, FCGFH which reported 131 trades and SBTT with 104 trades.
- FCGFH, RFHL, SBTT and MASSY traded on all 22 trading days while NEL traded on 20 out of the 22 trading days during the month of January 2024.


Across the First-Tier, Mutual Fund and SME markets, the cumulative number of trades in January 2024 was 1,529, an increase of 14 trades or 0.92% compared to the trading activity in December 2023.

On a YOY basis, total trades recorded in January decreased by 111 or 6.77% over January 2023's trading activity.

On average, there were 70 daily trades recorded in January 2024 (December 2023: 80 trades), in comparison to the daily average of 78 trades recorded during January 2023.



Bid-Ask Spread




